# **Steps to Prepare Before an Accident Occurs:**

- 1. Keep a copy of Hardy Wolf & Downing's Car Accident Checklist in your vehicle
- 2. Always have your insurance card, driver's license, and registration with you when you're driving
- 3. Keep a safety kit in your vehicle

# Steps to Take Immediately After a Car Accident Occurs:

## 1. Check Yourself & Others for Injuries

**TIP:** If you or someone else is injured, call 911 or ask someone nearby to do so. If you're seriously injured, try not to move and wait for first responders to arrive.

#### 2. Contact Law Enforcement

TIP: Always call the police immediately to file an accident report.

#### 3. Preserve the Scene

TIP: Avoid moving the vehicles involved unless it poses an immediate hazard.

TIP: If you must move the vehicles, make sure to take photos of the scene before the vehicles are moved.

#### 4. Gather Witness Information

**TIP:** Speak with on-scene eyewitnesses and collect their names and contact information, do not rely on law enforcement to do this.

### 5. Exchange Insurance Information

TIP: Collect insurance information from all involved drivers.

#### 6. Avoid Admissions of Responsibility

**TIP:** Do not admit fault or assume blame, even if details are unclear. **Note**: When filing an insurance claim, the adjuster assesses fault by inspecting damaged vehicles/property, considering information from all involved parties, and reviewing supporting documents such as police reports and scene photographs.

#### 7. Document the Accident

**TIP:** Write down your recollections of the collision while they are fresh.

TIP: Request a copy of the accident report number from the police on the scene.

**TIP:** Document the accident with your own pictures and video (taken from multiple angles and damage done to both vehicles).

# 1. Consult with an Attorney / Call 1-800-INJURED

TIP: Follow all medical advice from your physician, including medication and physical therapy.

TIP: Keep detailed notes and records of all treatments.
